



## CANADIAN MASTERS RECORD APPLICATION FORM

Records are recorded in all IWF weight classes (8 men, 8 women), in 5 year increments starting at age 30. The athlete must be a Canadian citizen or permanent resident and a member in good standing with his or her Provincial Sport Governing Body and with Canadian Masters Weightlifting Federation Haltérophilie Canadienne (CMWFHC). Athletes with dual citizenship must comply with IWF and IWF Masters rules (section 20.4 of the IWF constitution).

A record set at the following competitions will be accepted upon receipt of the official results by the Records Secretary (the record application form below is not required):

- World Masters Championships
- World Masters Games
- Pan-American Masters
- Canadian Masters
- World Cup
- Provincial Masters **only if the athlete meets/provides the following conditions:**

1. Must be a registered CMWFHC member.
2. The Application Records Form is filled out and signed by the referees who judged the lift/lifts and the Competition Director. At least two referees must be at the National Level or higher.
3. Details of the anti-doping policy/contract arranged for the Provincial Championships must be made available for review and/or verification by the CMWFHC anti-doping committee with CCES. (*Competition Director completes this on the Application Form*)
4. Prior to the competition date, the Provincial anti-doping committee must agree that the CMWFHC-ADC will be immediately made aware of any positive test results from CMWFHC members. (*Competition Director completes this on the Application Form*)
5. The completed Applications Records Form, provided below, is submitted to the CMWFHC Records Secretary.
